Resolution Directing Engineer to Prepare Plans and Specifications, motion by Welder 2nd by Salwei to adopt the resolution, roll call vote 4-0, Roth & Opsahl were absent. BND Loan Funds was approved for an infrastructure loan for 10 years @ 2%, motion by Salwei 2nd by Welder to accept offer and have Mayor and/or Auditor sign the paperwork, roll call vote 4-0.

City/County ownership roads were discussed. Motion by Lipp 2nd by Welder to hire Kara S to do the research, roll call vote 5-0.

25-2 project was discussed.

NEW BUSINESS-Piatz from the park board presented a worksheet proposing a redistribution of the city sales tax proceeds percentages to be placed on the ballot for June election, motion by Welder 2nd by Salwei to place on the measure on the ballot, roll call vote Lipp-n, Welder-y, Eiseman-y, Roth-y, Salwei-y 4-1.

The current tax distribution is 25% City, 25% Park, 25% Swimming Pool & 25% JDA. If approved by the voters in the June election, the new distribution will be 25% City, 20% Park, 50% Swimming Pool & 5% JDA.

Sausage Facility/sewer-Motion by Welder 2nd by Salwei to approve Deile's request to hook into City sewer for the meat plant, with all expenses paid by the Deile's, roll call vote 5-0

Motion by Salwei 2nd by Welder to approve the HP All-in Plan for a printer, roll call vote 5-0.

Street Report-Zach's Review was discussed. Water testing was discussed.

Sewer Issue (Roger's Letter) was discussed.

Salwei presented a bid from Stewart signs to update the Badger sign for \$21,702.18, motion by Roth 2nd by Eiseman to approve, roll call vote 5-0.

Welder-Reported water damage again in the Civic Center.

Lipp-will check with Kauk on the road closed barriers.
